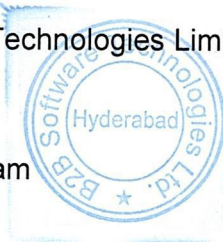

We have reviewed the accompanying statement of unaudited financial results of **B2B Software Technologies Limited** for the period ended 31<sup>st</sup> December 2018 prepared by the Company pursuant to the requirements of Regulation 33 of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015, read with SEBI Circular No. CIR/CFD/FAC/62/2016 dated July 5, 2016.
